Conditions	General	<p>The tournament will be played in accordance with the Laws of Badminton, the BWF General Competition Regulations and Badminton Europe Elite Circuit Regulations. In case of any dispute, the Referee's decision shall be final.</p> <p>Member and/or organizer may be liable for claims originating from the damages incurred by the participants and/or any other persons, arising from or in connection to the particular BEC tournament, according to local Law. Badminton Europe is not liable for any such claims, actions, damages, costs or expenses of any nature whatsoever, including but not limited to injury or loss to person or property, arising out of or in any way related, directly or indirectly, to the particular BEC tournament. It is recommended that Members and/or Organizers purchase a proper Insurance Policy that would cover their potential legal liability (see Elite Circuit Regulation 3.6).</p> <p>The organizing Member can cancel a tournament in case of force majeure. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, then the Member organizing the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.). Badminton Europe is not liable for any costs incurred by third persons because of a cancellation of a tournament. (see Elite Circuit Regulation 3.4).</p>
	Entries	<ol style="list-style-type: none"> 1) Only entries that are entered by Members through the online system at https://bwf.tournamentsoftware.com/tournament/365D132C-946A-4E90-8608-C86C762C3E02 will be accepted. If needed, Members can obtain the required username and password from BWF's Senior Events Officer: s.ramachandran@bwf.sport. 2) Entry deadline is Tuesday March 15th, 2022 - 23h59 BWF headquarters time (+08h00 GMT). 3) After the deadline, the BWF Online Entry System will send a notification confirming receipt of final entries to all participating Members. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline. 4) Compliance with GCR 7.9: "In making or authorizing entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

VISA procedure

Competitors and officials who need Visa for the Netherlands, should send the Visa application form not later than February 28th, 2022, to the tournament secretary (secretary@dutch-international.nl). We will not accept entries needing visa without such an application. The Visa application form is published on the tournament's webpage and all requested information (full names, dates of birth and passport numbers of all players and officials) should be provided.

Events

- 1) The draw sizes of the main events will be as follows: 32 MS, 32 WS, 24 MD, 24 WD and 24 XD. The M&Q Report will be published on March 18th, 2022, and will be based on the World Ranking dated March 15th, 2022.
- 2) In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.1: World Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking, i.e. BEC Elite Circuit Ranking and BWF World Ranking.
In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.1: World Ranking System, the first published version of the main draw of an event must contain at least 1 (one) entry from a Member other than the hosting Member. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member, this particular event shall not count towards any ranking.
Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings (see Elite Circuit Regulation 3.3).
- 3) Members will be acknowledged as to which of their entries have been accepted into the Main Draw, which are required to qualify, and which are on the lists of reserves.
- 4) Seeding and draw will be done by Badminton Europe, based on the World Ranking dated March 22nd, 2022.
- 5) The draw will be made by Badminton Europe, on Tuesday March 29th, 2022.
- 6) The final frame schedule (with the exact planned conclusion of all matches) shall be made at least 20 days before the start of the tournament and shall be published on the organizer's website.
- 7) Players shall not plan their departure less than two (2) hours after their last match is planned to conclude. If a player is unable to compete due to early departure, he/she will be penalized by removal of BEC ranking points and shall not be awarded prizes or prize money. Badminton Europe shall propose to BWF that the gained BWF ranking points are also removed.
- 8) Please ensure that the Secretary of the Committee of Management is informed immediately when a player has to withdraw, preferably together with the reason.

Attention:

- a) Any withdrawal after the Monday immediately preceding the draw (March 28th, 2022), for any reason whatsoever, renders the Member concerned liable to an amount of US\$ 150,00 for the inconvenience

caused by the withdrawal (as defined in BWF General Competition Regulations).

- b) Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the “no show” (as defined in BWF General Competition Regulations).

Match conditions

- 1) Competitors must be prepared to play at the times quoted in the Order of Play for the events for which they have entered. No exception shall be made to this rule.
- 2) Matches will be played according to BWF laws.
- 3) The period for knocking-up before any match shall not exceed 3 minutes.
- 4) The tournament’s official shuttlecock is the adidas Flieger FS7.
- 5) Testing for the use of drugs can be conducted throughout the tournament.

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). - 6) During the entire tournament, two courts will be equipped to enable betting. For these courts, a specific order of play might be announced. Badminton Integrity: Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament. To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches. - 7) During the event, stringing service will be present.
- 8) The managers’ meeting is scheduled for Tuesday at 19h00 in a signposted room at the tournament venue.
- 9) Booking of training courts is available on our website from the beginning of March 2022.
- 10) The matches will be played on Yonex courts.

Clothing and advertising

Colour, design, lettering and advertising on clothing shall be regulated by BWF General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to BWF.

It is mandatory that partners in doubles wear the same colour of the T-shirt and shorts/skirts at all time during play in both the qualification and the main draw. Failing to do so shall result in an administrative fine of 100,00 EUR.

Entry fees	<p>Singles, per competitor € 60,00</p> <p>Doubles, per competitor € 55,00</p> <p>The Member that enters a player into a BEC tournament is responsible for paying the entry fees for that player. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. Please note that entry fees will not be refunded in case of withdrawal after March 15th, 2022 (see Elite Circuit Regulation 17.1). The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organizers can invoice the entry fee to the relevant Member (see Elite Circuit Regulation 17.2). Entry fees must be paid before a competitor plays his first match in the tournament. The fees must be transferred to our Rabobank account. Bungalows

VELO Badminton can offer you an attractive arrangement to stay at the beautiful “Kijkduinpark” (Machiel Vrijenhoeklaan 450, Den Haag). This is a park with chalets and villas directly on the shore and at a 10 minutes’ drive from the tournament venue. “Kijkduinpark” offers a lot of facilities to comfort your stay during the tournament: free swimming pool, supermarket, restaurants, bar, snack-bar, tennis courts, golf court, and of course the Dutch coast. Breakfast is available but not included in the accommodation prices.

We offer you a choice between two types of chalet:

- Type A (chalet)..... € 1.075
 - Maximum of 4 persons
 - One bedroom with a double bed (2 mattresses) and one bedroom with two single beds
 - Bathroom with shower, washbasin and toilet
 - Kitchen with microwave and gas cooker
 - Living with TV
- Type B (villa) € 1.375
 - Maximum of 6 persons
 - Three bedrooms, one with three single beds, one with two single beds and one bedroom with a double bed
 - Bathroom with shower and bath/whirlpool
 - Second bathroom with shower, second toilet and sauna
 - Fully equipped kitchen with microwave and dishwasher
 - Living with TV and fireplace

Rental conditions

- 1) The chalets and villas can only be rented for at least 5 nights (arrival on Monday April 11th, 2022, departure on Saturday April 16th, 2022) for a fixed price, see the reservation form.
- 2) Costs include sheets, towels, tax and cleaning.
- 3) Reservations must be made before March 25th, 2022.
- 4) Transfers by minibus from Amsterdam Airport Schiphol to “Kijkduinpark” v.v., and transfers from “Kijkduinpark” to the tournament venue (approximately every half hour) are also included, in the period April 12th - April 16th, 2022.
- 5) The organization committee is willing to look at the possibility if chalets and villas can be shared with participants from other groups if desired, but cannot give any guarantees that such attempts will be successful.
- 6) Costs of chalets and bungalows should be paid in advance with the entry fees of the tournament. Please indicate the type(s) of chalet/villa and the number(s) of persons in a chalet/villa. If cancellations of chalets

and villas at the “Kijkduinpark” are made after March 28th, 2022 the full amount due will be charged, refund is impossible.

To this end, we will send a separate form to the countries where this applies after registration for the ADIDAS Dutch International has been closed. To fill in that form we need the following information per person: name, role (athlete or supervisor), passport number, date of birth, date of travel, place of origin, date of departure and travel destination.</p> <p>b) Every person must complete the 'quarantine declaration' form and be able to hand it over to the authorities upon arrival in the Netherlands.
